Requirements:

Skaters are required to demonstrate the following elements during the try out dates.

- Forward Crossovers
- Stroking
- Snowplow Stop with Control
- Pick up stuff animals and skate without dropping them

If selected, the following additional requirements must be met.

- Parents will be required to volunteer to assist during a shift with the ice sweepers
- Be available to ice sweep during Wednesday, December 15 through Sunday, December 18
- Ice Sweepers may need to miss school during the event
- Member of U.S. Figure Skating with Basic Skills or club membership

Try Out Dates

Salt Lake Figure Skating will provide two try out dates at the Salt Lake City Sports Complex. Only attend ONE try out date. A \$10.00 fee is required to try out. (If the skater is selected, the \$10.00 will apply towards the fee.)

Waiver and Release and Assumption of Risk Agreement**

In consideration of me being permitted to participate in any way in **U.S. FIGURE SKATING** and **SALT LAKE FIGURE SKATING** sponsored activities ("Activity"), I agree to the following:

1. I FULLY UNDERSTAND that: (a) **U.S. FIGURE SKATING** and **SALT LAKE FIGURE SKATING** activities involve risks and dangers of **SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH** ("Risks"); (b) these Risks and dangers may be caused by my own actions or inactions, the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I **FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES** incurred as a result of my Participation in the Activity.

I further agree and warrant and will instruct the Minor that if at any time the Minor believes conditions to be unsafe, he/she will immediately discontinue further participation in the Activity.
